### IPT Qualifying Tournament Entry Form

Here is your opportunity to secure a spot in an IPT 2006 Tour Event! Use this form to enter into any number of IPT Qualification Tournaments. Tournaments are double-elimination and races are to ten. Two players from each tournament, no matter how many players participate, will win a place in an IPT Tournament. The two winners will be the winner of the winning side and the winner of the one-loss side of the double elimination brackets. IPT Rules, which can be read at [www.internationalpooltour.com](http://www.internationalpooltour.com), govern each tournament. Space is limited, so entries are based on a first-come, first-served basis. Do not miss this chance to play on the IPT tour by failing to register in time. Absolutely no entries will be allowed at the tournament; no money will be accepted at the events. There are two entry fee levels for IPT Qualification Tournaments. A full entry fee is \$1000. If a player qualifies to play in an IPT Tournament at this level, all winnings earned at this entry fee level will count towards the top 100 Money List, which wins a player a 2007 IPT Player's Card. All 2007 IPT players are guaranteed \$100,000! The second entry fee level is \$500. Players who qualify at the \$500 entry fee level will receive 50% of any prize money won and prize money will not count towards the Money List.
